President's Report: Mary Todd ordered a "Books for Babies" kit; it has not arrived yet; we can discuss next month.

Book Sale: Belindia. Donation day is October 1 from 9 am – noon; volunteers are needed.

Belindia has registered FOL for the Amazon Smile program and the scanner program. Emails will be sent to Bonnie as she monitors the FOL email account; Bonnie will complete the registrations for both programs. Belindia found bookcases that we could use for the DVDs and CDs; cost is \$30 each. We may have an opportunity to purchase similar units from a different source. Roxy moved to allocate up to \$100 to purchase such units, second by Mary Maloy; motion carried. Linda Ptack and Belindia will coordinate efforts for the purchase.

Culvers: thanks to Lisa for scheduling workers to take books to Culvers. Discussion on whether it was financially feasible to continue that project. The audit committee looked at the total Culvers income versus the total sales tax we pay for the two major book sales and the Culvers sales, and found we are still ahead as Culvers revenue exceeds sales taxes. The best sellers are children's' books, romances and current or library culls of mystery novels.

Attendance at **Library Board meeting**: Roxy gives a short presentation at the library board meetings; she reported that the audit committee had met and all is good; she reported on the upcoming donation date and book sale dates.

Audit Committee: Angelique: The check book balanced. As a 501(c)(3) organization, financial records must be available to the public. We need to figure out how to handle any requests to view the records. She asked the program committee to include a copy of the contract and a form which, Kate has prepared, when requesting a check for a program. The forms are in the FOL mailbox.

A **locking file cabinet** is needed to keep our records safe. Roxy will check at Costco to see how much a 4 drawer locking file cabinet costs. Kirstin will suggest where we might put the file cabinet.
