Smokestack height is issue

CARPENTERSVILLE - Cargill officials may have jumped the gun.

Second District Appellate Court Judge Alfred E. Woodward overturned a ruling that allowed a 100-foot exhaust stack for the firm's liquid waste incinerator. However, the stack has operated since June.

"We're discussing the possibility of appealing," said Cargill General manager Pat Heffernan. "We have until Dec. 20 to make a decision."

Last year, the Illinois Environmental Protection Agency told Cargill officials that a 25foot stack had to be made taller before the Cottage Avenue paint resin manufacturer would be given a permit to burn hazardous liquid waste. Village ordinances prohibit structures from exceeding 35 feet and local officials denied Cargill a variance to build the

Anticipating the village's refusal, Cargill appealed the IEPA's requirement to the state Pollution Control Board. The pollution board ruled that the IEPA's decision pre-empted the local ordinance.

Woodward reversed that decision and returned the case to the Pollution Control Board to determine whether the taller stack is needed.

The IEPA established the stack height at 2 1/2 times higher than the nearest obstruction to allow emissions from the chimney to disperse. The nearest obstruction is a bluff.

The height of the stack was not the issue. Heffernan said. The issue was whether the local ordinance was superceded.

"The people of Carpentersville are interested in Cargill taking whatever steps to abate any pollution. It's ridiculous for the Village of Carpentersville not to want the cleanest air they can get."

Constructing the smokestack was the first measure to improve air quality, Heffernan said. If the stack is not permitted, the firm will look for other ways to operate the incinerator, he added.

The incinerator was shut down in 1986 after area residents complained of odors being emitted from the plant. Cargill began hauling the hazardous waste, a byproduct from resin and paint manufacturing, to an off-site dump. Hauling the material was costing the company \$60,000 to \$70,000 a month.


The IEPA issued Cargill temporary permits to use the shorter stack for emissions testing. The incinerator has been back in operation for more than a year.

The company began using the new stack in June. It was built without a village permit.

"Cargill knew there was a question of the stack's legality," said IEPA spokesman Stan Black.

"I don't think anybody ever proved to the village that the stack was going to get rid of the odor," said Carpentersville Village Presi-
